Substantial educational support comes from the parish, and fundraising activities. School families provide volunteer and fundraising support to further the educational goals of the school. All families are required to commit to a minimum of 10 hours of service within a given year (July 1, 2012 – June 30, 2013). In addition, participation in two annual fundraisers is obligatory. Families are required to work two – 4 hour shifts at the SJB Road America Concession Stand. Also, participation in the annual Home & School Association fundraiser (currently the candy sale) is required. Families may choose a payment “opt-out” for either fundraiser.
